Notification of Levy by Instalments

IMPORTANT

A levy payer may apply to NT Build to pay the levy by instalments if the value of the levy exceeds \$10,000 and the project is expected to take more than one year to complete. As a general rule, the first instalment should be no less than 50% of the total levy amount payable, with the balance to be paid in two equal instalments.

The Board may approve or refuse the levy instalment proposal or decide to vary its terms.
